Scope of Services

For all opensource software technologies, implementation, support and maintenance is the key to making adoption of system successful. We offer package custom designed keeping in mind your needs for the implementation. The services which can be covered under this dedicated resource based implementation package are as below.

1. User Training

User training is crucial to make users adopt ERP effectively. Here we conduct module wise training for your company to implement ERP successfully. During training sessions we also note down required configuration for each module. These configuration can be carried out post training session to make ERP Suitable for your business.

- a) The training session can be demo of specific module or for requirement gathering.
- b) We can arrange training sessions for your internal project in charge or for team members.
- c) The training session can also be required for any specific challenge you are facing in ERP.
- d) In most cases there are some pre-checks on configuration for each module, the consultant needs to carry out before conducting user training sessions. So it's generally requested to be planned minimum 2 days in advance.



2. Functional Guidance

Given the large scope of ERP, to get maximum out of available features, users may need expert support to carry out operations smoothly.

- e) We will provide needed handholding on technical doubts regarding ERP.
- f) The doubts can be related to any new or existing features of ERP.
- g) For non-technical training, the user will be guided to use existing documentation, support will be limited to clearing the doubts.
- h) It is suggested your company must designate a maximum of 2-3 people to co-ordinate on user queries, all user queries should be routed through them, this will reduce your support cost as queries will be better filtered at your end.



3. Role permissions

The Access right management in ERP has been designed in two stages. First User roles (eg Sales User, Sales Manager, Stock Manager) are created. Then access rights to various documents (eg Customer/ Lead etc) given to user roles. Any new user can be assigned one or more User Roles will give him access to all the documents allowed to the assigned User Role. Further, you can restrict access of user to specific permitted documents through User Permissions.



- Finbyz will provide needed guidance on creating User Roles and User Permissions.
- The discussion can cover how to achieve decided objective of user permissions within the existing role permission framework structure.
- Finbyz will also support you on changing the field permission levels to achieve desired results.

4. Workflow Design

With workflows you can rewrite how a particular document / transaction is approved in ERP. You can set multiple levels of approval for any specific document like purchase order, sales invoice, leave application etc. through workflows. Our support service will cover below points on this.



- Guidance on creating workflows in ERPnext for the set objective.
- Discussions on required roles and user permissions for managing workflow objectives.
- Setting up email alerts for different workflow states through standard features.

5. Print Formats

Print formats of any document are the way any external or internal person is review that document. Erp allows you to build or configure multiple print formats for any document through Print format builder or custom print format.



- Finbyz will provide needed hand-holding for changing print formats through print format builder.
- Any minor changes to existing custom print formats can be done as per user request.
- We can also design custom print format written in Jinja templating language for any document.

6. Notification Settings

You can configure various notifications for users, customers, suppliers etc. through Email, whatsapp (Subject to additional service) or system notifications. These notification can be triggered on various document events like save, submit or on specific method.

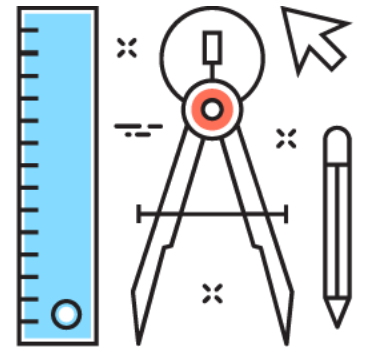
- Finbyz will create required alerts with dynamic content. These will be designed in HTML templates with required jinja formatting by developer.
- If whatsapp integrations is subscribed, we can also set approved templates with dynamic content as alerts for whatsapp messages.

7. Report Configuration

ERP allows you to build custom reports using report builder functionality. Further you can also customize existing reports by adding related columns or removing related columns. Still user may require some hand holding for making these changes for desired data.

- Finbyz can suggest you which report has most relevant data which you can customize to get your desired functionality.
- Finbyz will support you in generating required reports with effective use of standard auto filter function.
- We will also help you set up required auto email report functionality.
- If totally new report to be developed we can also achieve it through custom script report or sql query.



8. Data Import

All the documents in ERP are importable through an excel file. However before importing any data, one must understand existing data structure of ERP, and convert the data provided in the format acceptable for ERP. This data cleaning and pre-processing is time consuming activity.

- Finbyz will help you understand ERP's data structure to prepare required data import format in excel.
- We can help you preprocess data to be imported in the system.
- Add custom fields as per data provided to capture full information in ERP.
- Create multiple import files as per ERP format to import data in related linked doctypes to import the main file.

9. Server Support

Onsite Deployment Terms

If the project requires the resource to be available onsite for a certain number of days, Finbyz Tech is committed to providing this flexibility. The following terms will apply:

Resource Availability Onsite:

The resource will be made available onsite at your location as per the project's specific needs. The minimum notice period required for scheduling onsite deployment is 10 days. The duration of onsite deployment will be limited to maximum 15 days per visit.

Client-Responsibility for Major Expenses:

The client will be responsible for covering or reimbursing all major expenses associated with the onsite deployment. These include, but are not limited to, the following:

- **Travel Expenses:** Airfare, train, or other transportation costs to and from the client's location.
- **Lodging:** Accommodation expenses for the duration of the onsite stay.
- **Meals:** Daily meal expenses beyond what is covered by the per diem.
- **Local Transportation:** Transportation costs incurred while the resource is onsite, including taxis, ride-shares, or car rentals as necessary.

Per Diem Cost:

A per diem charges for per day/per resource will apply for each day the resource is onsite. This per diem is intended to cover incidental expenses such as local travel, minor meals, and other day-to-day expenditures that the resource might incur. This amount is in addition to the standard monthly rate of resource and major expenses mentioned before.

This ensures that the resource can focus on delivering high-quality work without being concerned about out-of-pocket expenses for minor daily needs. The per diem allows for smooth and efficient operations while onsite, ensuring that the resource remains productive and fully dedicated to your project.

Payment Terms

Initial Advance Payment:

For no commitment contract, there is no initial advance payment required. The client can choose to start the service at full price without any discount.

For contracts with a 3-month commitment, an advance payment equivalent to the first month's billing is required upon signing the contract.

For contracts with a 6-month commitment, an advance payment equivalent to 1.5 months of billing is required upon signing the contract.

Monthly Payments:

Whichever contract you choose, each month billing will be done at beginning of the service period and will be due within 7 days.

Please note this billing is in addition to advance collected for commitment period.

Advance Adjustment:

The advance payment will be adjusted against the final month(s) of the contract. For a 3-month contract, the advance will cover the last month. For a 12-month contract, the advance will be spread across the last 1.5 months of billing.

Onsite Deployment Charges:

All onsite deployment expense either should incurred by client or should be paid in advance. Per diem charges for selected tenure should be paid before travel date.

Penalty-Free Exit Clause

If the client decides to terminate the contract before the agreed commitment period, they can do so by providing a **30-days** (For 3 month Contract) **and 45-Days** (For 12 Month Contract) written notice.

The advance payment will be non-refundable, but will be adjusted against the service provided in the notice period. There will be no additional penalties imposed. This clause reassures the client that they have flexibility while reinforcing the importance of the advance payment.
